Re: Jim's Fast-Track Assembly Method

We are enabling our Forum at <u>IndianaRepublic.Us</u> and most members should now be able to register.

I have been following all the news of the Collapse and Reset for about 15 years. My free news blog is <u>Resetus.us</u> Everything I know and see tells me the collapse can occur any day. If that is the case then Indiana must be prepared to Stand Up and in turn cause the Federal Republic to Stand Up.

Indiana needs to very quickly establish at least 16 active County Assemblies that have organized and completed their work. By following the steps outlined below, you can organize your county in about 30 days.

The biggest problem all are having is confusion over how to create an Assembly (Association).

Many attempting to restore the Republic or to become a Sovereign believe it must be complicated and done the way someone did it in the 1700s.

There is a lawful Fast-track method to do this. It is done every day in our country. Every time a corporation, (Microsoft), a Partnership (Law Firm) or Association (The Lions Club) gets started their attorney draws up the paperwork and files the paperwork to create that entity. They select an appropriate set of By Laws for it and declare the organization's purpose.

When it is all set to open that shell for business, the original stockholder(s) partner(s) or Founder(s) then **Open** the first meeting and **Ratify** (accept) the work done by the one who pushed the paper. The mere act of accepting (ratifying) the paper means that it is now lawful, even if it wasn't before that meeting.

That meeting is called the "Opening Meeting". Thereafter anyone else joining needs not sign in blood. By merely joining they ratify the opening documents as well.

The Fast Track Plan:

- A) Have from one to five persons hold a meeting of the mind(s) to accept the suggested sample **By-Laws** (in our Toolkit). Write your County's name on it, vote to adopt them. Elect a Moderator, Scribe & Bailiff. Have them sign and date the newly adopted By-Laws of your County Assembly.
- B) Have a meeting of the mind(s) for one to five persons to sign the sample **Bilateral Social Contract Agreement** (in our Toolkit).
 - Write in your county's name. Vote to Accept & have it signed & witnessed.
 No one outside of the membership will ever see this Contract/List of grievances.
 - C) This concludes two thirds of the work required by the Assembly. The final step is to elect or get two volunteers to occupy two seats in the State House of Representatives as Pro Tem (temporary) until the restored Republic stands up and have elections in 120 days. Also, you will need to Select an interim County Clerk and an interim County Justice.
 - My guess is these two state delegates will only have one main task to do...to vote for Indiana to join the National Republic For The United States. The sooner you get the two to represent the county, the better.
 - D) As chaos draws more persons to join the effort to Re-Inhabit the Republic, they too will ratify the Opening meeting by merely joining the Assembly.
 - E) The Opening meeting can be in one room, the result of several phone calls or a Zoom meeting. The election/volunteering process can be done by email, in the Forum room or in a private meeting room. When I was bringing up Assemblies 15 years ago, I reserved free Library meeting rooms under the name of Toast Masters Club to be more discreet.
 - F) When you have adopted the two forms, go to the website forum and announce that you volunteered and adopted and now are ready to select two delegates. Any Volunteers?
 - G) Contact Indiana's interim Secretary of State for instructions to connect your county with the national RRfortheUSA.
